Polish Heritage Month is behind us. On Sunday morning, October 6, for the 87th time, the Polish American community gathered in the heart of



New York City to express their unity, remembrance and pride in being Polish. The 87th Pulaski Parade was held in New York City on Sunday, October 6, 2024. This is one of the most important events for the Polish-American community, which pays tribute to General Casimir Pulaski - a Pole who gallantly served in the fight for the independence of the United States - and also promotes Poland on American soil. This year's event was held under the slogan "Because freedom is measured by crosses." The quote comes from a military song written during the battle of Monte Cassino titled "Red Poppies on Monte Cassino." The choice of the slogan of the Pulaski Parade, which has been organized since 1937, is not accidental and is connected with the 80th anniversary of the Battle celebrated this year.

Anna Maria Anders, Ambassador of the Republic of Poland to Italy and San Marino, and privately the daughter of General Wladyslaw Anders, who commanded the Second Polish Corps in the Battle of Monte Cassino served as the parade's honorary Grand Marshal. The celebration began at 9 a.m. with a solemn Mass at St. Patrick's Cathedral, followed by the red-and-white parade on Fifth Avenue at 12:30 p.m.

The ceremony attracted thousands of participants and spectators, among whom were leaders and employees of Polish organizations, Polish schools, representatives of the clergy, as well as invited guests and local authorities. Representatives of Polish state authorities were present on the day. Consul General of the Republic of Poland in New York, Mateusz Sakowicz, also participated in the Parade. The Marshal of

this year's Pulaski Parade was Piotr Prasz-kowicz, a businessman who has been supporting Polish-American initiatives in the United States for years. Just like last year, the Parade was attended by New York City Mayor Eric Adams, who strongly supports ethnic groups in the city. PSFCU was represented by a large group of participants, including members of the Board of Directors, Management, as well as employees with their families. The Polish and Slavic Federal Credit Union contingent was vocally supported by Kaeyra, a young Polish singer who is also the winner of our PSFCU Rising Star Scholarship.

"Our Credit Union has been participating in this Parade since its inception, giving an expression of Polishness, unity and tradition. I'm glad that for many years now we have also been the main sponsor of the Pulaski Parade. It is a tremendous honor for us to be able to sup-

port one of the most important Polish events in the United States in this way." - emphasized PSFCU President/CEO Bogdan Chmielewski.

The Pulaski Parade is a way to nurture national identity, bringing together generations of Poles, as well as lovers of Polish culture in a joint march. Through fun and song, Poles strengthen their sense of community, passing on the memory of Poland and its history to future generations. As every year, the event kicks off the festive celebration of Polish Heritage Month, commemorating gen. Casimir Pulaski, whose courage and heroism have become a permanent part of the history of the struggle for U.S. independence.
